1. The special inspection agency shall be employed by the owner, or, the engineer or architect of record acting as the owner's agent.
2. Contractor is responsible for proper notification to the special inspection agency for the items listed.
3. Only special inspection & testing agency personnel are to take samples and transport them to their laboratory.
4. Copies of all laboratory reports and inspections are to be sent directly to the City by the special inspection agency.
5. The special inspection agency is to submit the names and qualifications of on-site special inspectors to the Building Department for approval.
6. The Special Inspector is under the authority and is responsible to the Building Official. All concerns and/or problems encountered are to be brought to his attention immediately.
7. Special Inspectors shall provide weekly reports to this Department of all inspection activity.
8. It is the responsibility of the contractor to review City approved plans for additional inspection or testing requirements that may be noted.
9. BEFORE AN OCCUPANCY PERMIT CAN BE ISSUED: The Inspection agency shall submit a statement that all items requiring testing and inspection were fulfilled and reported. Those items not tested and/or inspected shall be noted in this statement. Copies of statements to be maintained at the job site for City's Building Inspector's review prior to final inspections.
10. NO WORK SHALL BE COVERED PRIOR TO CITY INSPECTION APPROVAL. PLEASE SCHEDULE AN INSPECTION WITH THE BUILDING DIVISION AT 650-853-3189.
