# APPENDIX III. COMMUNITY SURVEY DETAILED RESULTS

As part of the Urban Forest Master Plan development process, the authors engaged with over 350 community members to understand community perspectives on trees and to gather input about urban forestry needs in the city. One method of gathering input was an online survey distributed to community members to understand people's attitudes toward trees in East Palo Alto. The survey was conducted between April and August of 2021. Chapter 5 of the Urban Forest Master Plan describes the overall engagement approach and findings. This appendix contains the summarized survey results for all questions asked. Bolded question text is as-used in the survey, and exact answer options are given in the summary tables.

The results of this survey will inform the City's Urban Forest Master Plan and guide future tree maintenance and planting plans in East Palo Alto.



#### How do you feel about trees in your neighborhood?






#### 4. Where do you think more trees are most needed? (Below map provided with question)

#### Where do you think more trees are most needed?






















## How important is it to you to have a park within walking distance of your home?










#### In which neighborhood do you currently live?


### Do you rent or own your residence in EPA?



24. Which category below best represents the total combined income before taxes for all the people in your household for 2020?




## Which category best represents the total combined income for your household for 2020?


