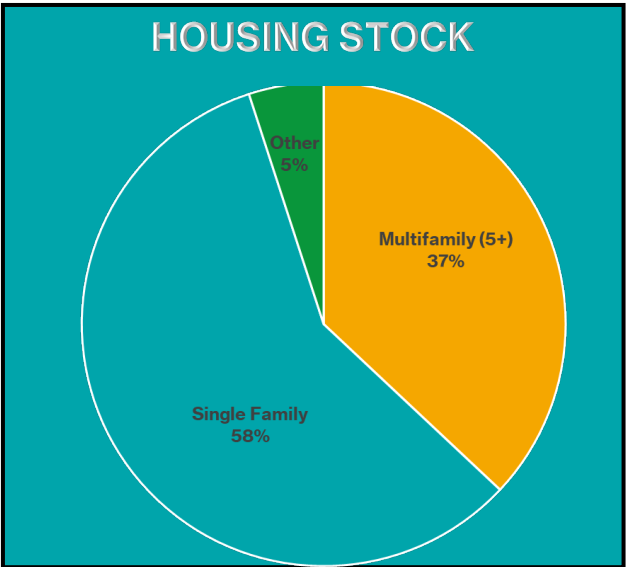

4.8 Environmental Justice Element

I. Overview

This Environmental Justice (EJ) element section within Chapter 4 of the General Plan Guidelines includes:

- » A brief history of EJ in California
- » A summary of Senate Bill 1000 (2016), which established EJ requirements for general plans under Government Code Section 65302(h);
- » A summary of the regulatory and policy context related to EJ;
- » Guidance for determining whether an EJ element or equivalent is required in a local jurisdiction, including identifying the location of disadvantaged communities (as defined in Gov. Code, § 65302, subd. (h)(4)(A)) as well as the nature of their environmental burdens, health risks, and needs;
- » Guidance for community engagement when addressing EJ and disadvantaged communities; and
- » Guidance for developing EJ goals, policies, and programs that address the unique and compounded health risks in disadvantaged communities and prioritize improvements and programs that meet the needs of disadvantaged communities.

7. Health and Equity

Safety Element

Introduction

The goal of the safety element is to reduce the potential short and long-term risk of death, injuries, property damage, and economic and social dislocation resulting from fires, floods, droughts, earthquakes, landslides, climate change, and other hazards. Other locally relevant safety issues, such as airport land use, emergency response, hazardous materials spills, and crime reduction, may also be included. Some local jurisdictions have chosen to incorporate their hazardous waste management plans into their safety elements.

The safety element directly relates to topics also mandated in the (1) land use, (2) conservation, (3) environmental justice and (4) open-space elements, as development plans must adequately account for public safety considerations and open space for public health and ecological benefits often incorporate areas of increased hazard risk. The safety element must identify hazards and hazard abatement provisions to guide local decisions related to zoning, subdivisions, and entitlement permits. The safety element should also contain general hazard and risk reduction strategies complementary with those of the [Local Hazard Mitigation Plan \(LHMP\)](#). Ideally, the LHMP will be incorporated into the safety element as outlined below in accordance with provision of [Assembly Bill 2140, General Plans: Safety Element \(Hancock, 2006\)\(Gov. Code § 65302.6\)](#).

The recent introduction of climate risk to the discussion of the safety element, adds a focus on longer term preparation of a community for a changing climate. Policies in a safety element should identify hazards and emergency response priorities, as well as mitigation through avoidance of hazards by new projects and reduction of risk in developed areas. As California confronts mounting climate change impacts, local governments are now required, in accordance with [Senate Bill 379, Land Use: General Plan: Safety Element \(Jackson, 2015\)](#) to include a climate change vulnerability assessment, measures to address vulnerabilities, and comprehensive hazard mitigation and

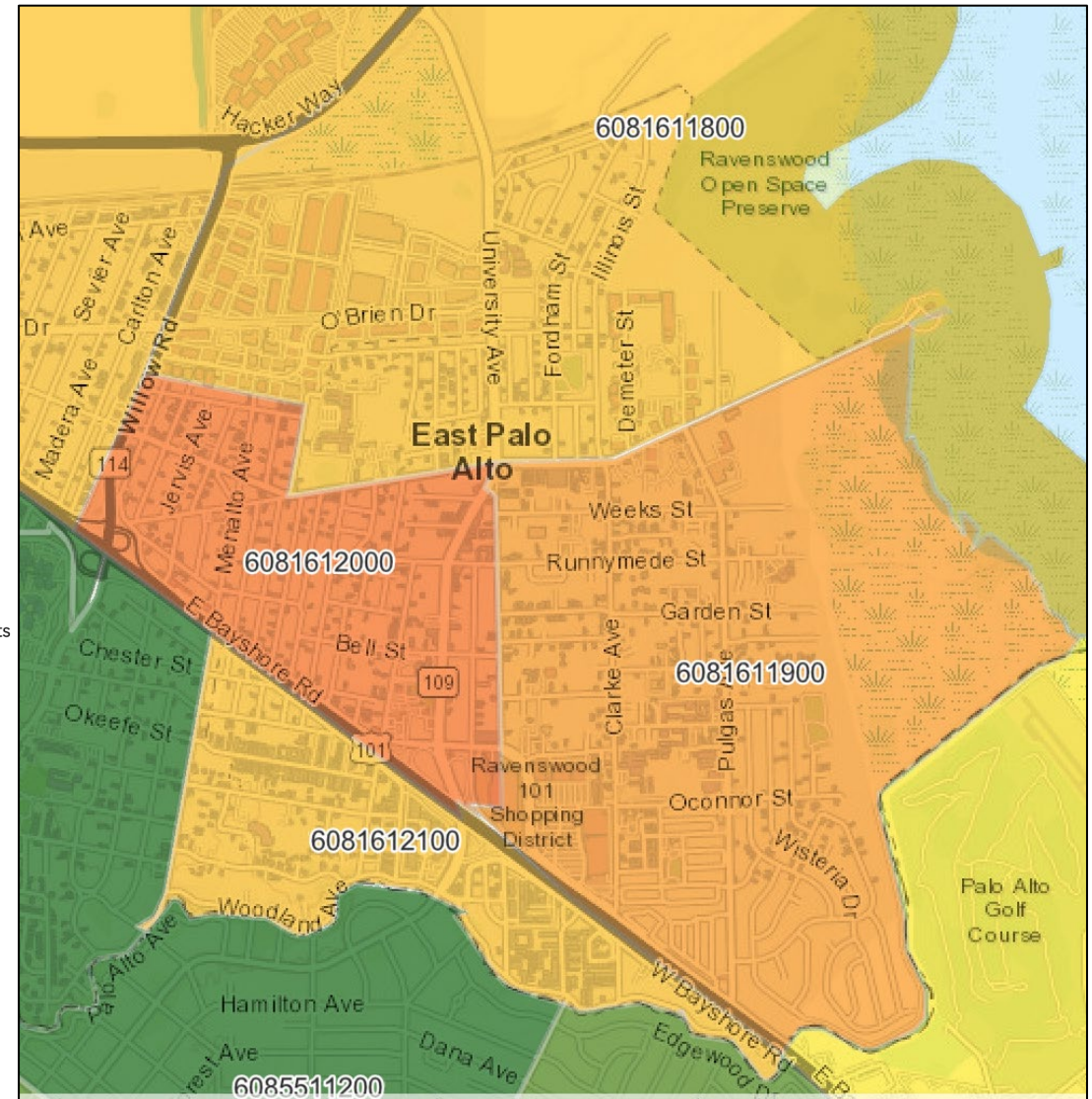

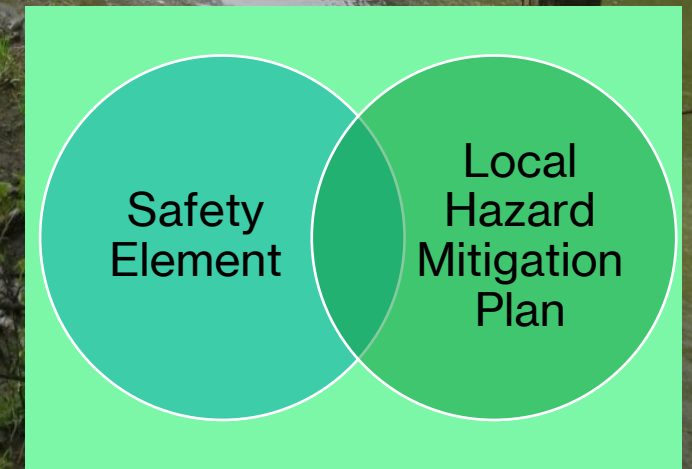
What is the Safety Element? / ¿Qué es el elemento de seguridad?

A chapter of the General Plan that must assess risk of/plan for:

- Tsunami/ *Tsunami*
- Flooding/ *Inundaciones*
- Fire/ *Fuego*
- Seismic risk/ *Riesgo sísmico*
- (NEW) “Climate change vulnerability assessment”/ *"Evaluación de la vulnerabilidad al cambio climático"*

Must show how the city will:

- Avoid or minimize climate change impacts (or other environmental risks) associated with new uses of land/ *Evitar o minimizar los impactos del cambio climático (u otros riesgos ambientales) asociados con los nuevos usos de la tierra.*
- Locate new essential public facilities outside of at-risk areas/ *Ubicar nuevas instalaciones públicas esenciales fuera de las áreas de riesgo.*
- Use “natural infrastructure” e.g. wetlands restoration or urban tree planting/ *Utilice "infraestructura natural", por ejemplo restauración de humedales o plantación de árboles urbanos*



Schedule for Safety and EJ Elements

- **Local-Jurisdictional Hazard Mitigation Plan (due in December); part of the Safety Element/ *Plan de mitigación de riesgos de jurisdicción local (que se vence en diciembre); parte del elemento de seguridad***
