The purpose of this letter is to request a complete street closure on all of E. Bayshore Rd from Pulgas Ave to Clark Ave for the Light Tree Apartments project located at 1805 E Bayshore Rd, East palo Alto.

Scope of Work

To install a new water main.

Work Dates Requested

05/26/2021-06/30/2021

Traffic Detours

As shown in the attached TCP we intend to close off both Southbound and Northbound lanes of E. Bayshore Rd. Traffic may be detoured using Clark Ave, O'Connor St. to Pulgas Ave. for Southbound traffic, and Pulgas Ave, O'Connor St. to Clark Ave. for Northbound traffic.

Emergency Fire/Ingress & Egress

We will use the existing *Emergency Fire Lane Entrance* of the Light Tree project located at the intersection of E. Bayshore Rd and Clark Ave. via our job site trailer.

Mobile Home Estates

Local access to the Mobile Home Estate Park will be maintained to the residence and the Fire Department, whereas the first northbound road closure is located just beyond the mobile home entrance. Residents exiting the Mobile Home Estate Park will exit southbound on to E. Bayshore Rd via the Pulgas Ave. intersection.

Construction Work Hours.

Construction work hours will consist of 7am -to- 4pm., unless otherwise noted by the City of East Palo Alto Engineering Division. East Bayshore Rd. will be reopened everyday beginning 4pm. as to relieve commute traffic.

CMS Notification

CMS boards will be used prior to the road closures in both directions, and if possible, shall state detour direction. The CMS board locations shall be placed per the City's direction. Any CMS board relocation shall be of the City's request.
