ADDENDUM 2

TRASH CAPTURE DEVICES INSTALLATION PUBLIC WORKS PROJECT NO. SD-08

To all prospective bidders, you are advised that the bid Documents for the above referenced Project are amended and clarified, as follows:

General Information and Questions

Question 1: Bid specs page 1, section 2.1 (2nd paragraph) states "Contractor to install 75 connector pipe screens with filters in existing storm drain catch basins…". What exactly is meant by "with filters"?

Answer 1: The filters means on REM filter as shown on the drawing details to be installed inside the stainless steel cartridge.

Question 2: Must any approved equals to the REM Crescent Pipe Screen contain an added filter component, or is any approved equal CPS device design that is certified by the Water Board acceptable?

Answer 2: See question #1 from Addendum #1. If the contractor wants to install different type of CPS certified by the Water Board, the contractor needs to provide cut sheet or detail for City review and approval.

Question 3: Bid specs page 10—What types of alternate bids might the Bidder provide that may be of interest to the City?

Answer 3: City is not interested in alternate bid for this project.

Question 4: Will the City provide an area for the Contractor to temporarily stage a roll-off bin for containing the extracted waste during the pre-installation catch basin cleaning process?

Answer 4: No temporary bin or stage area will be provided. All the debris and trash will be handled by contractor in their own cost.

Question 5: Will the City provide a secure area for storing equipment and materials during the CPS device installation process?

Answer 5: The chosen contractor can request it during the pre-construction meeting. Contractor should assume no temporary storing area will be provided.

Question 6: Technical Specifications, page TS-7, section 1.6—Please confirm if the preconstruction video documentation requirement will be waived for this project since it would be impractical given the moving crew from catch basin to catch basin.

Answer 6: The chosen contractor can request it during the pre-construction meeting. Preconstruction documents like video or picture is expected.

Question 7: Technical Specifications, page TS-7, section 1.7—Please confirm if the public notification requirement will be waived for this project since the installation crew will only be at each catch basin for approximately 30-60 minutes maximum. Otherwise this requirement will cause an unnecessary additional cost for the City.

Answer 7: The public notification requirement can be waived.

Question 8: Technical Specifications, page TS-15 (2nd paragraph, last sentence) states "Only individuals trained and certified in the principles of implementing traffic control and/or traffic control flagging shall be assigned that responsibility at the work site." Is this to say that the Contractor or Subcontractor performing traffic control must hold a C-31 specialty license for conducting traffic control procedures?

Answer 8: The City expects individual(s) who was trained for traffic control to work at the work site, and follow the City and MUCTD requirements as stated on the specifications.

Question 9: Technical Specifications, page TS-24, section 106—Is there any concrete replacement work expected as part of this project? There aren't any corresponding line items on the bid price sheet.

Answer 9: No concrete replacement work is expected unless the sidewalk, curb and gutter or inlet has been damaged during construction. Then the contractor is responsible to replace and repair in kind.
