General Information and Questions

- **1.** Is the city open to the bid items not specified as solar to be solar so long as the performance is equal?
 - a. 50/200 lights specified as "Solar Light"
 - i. Yes, the City is open to adjusting the bid item quantity; however, it depends on the field analysis/ field conditions. Any equivalent is acceptable.
- 2. What are the lighting requirements/specifications for each bid item?
 - a. I saw the attached specs though I am not seeing a clear indication of the light output expected for each line item. Required light output/specs will allow us to determine the required system size and price
 - i. All the available information is included in the bid package.
 - b. Lumens, footcandles, wattages, etc
 - i. Same response as above; please see the available information in the bid package.
 - c. Road classifications:

- **3.** Are there site plans or applications sites chosen or will these be determined after the lighting assessment?
 - a. It will be determined after the lighting assessment.
- 4. What all is required for the bid package; quote, design, datasheet, CSI spec, etc?
 - a. The required items include the bid schedule, alt item pricing, bid questionnaire, etc, as specified in the bid package.
- 5. Are all the lights existing or any new lights being installed?
 - a. It is a combination of both.
- 6. Solar system size/ specification list multiple; what should be used?
 - a. The one selected will depend on the field condition.

- **7.** What is the estimated construction budget?
 - a. No construction estimate is available.
- **8.** Bid Item 3 : Does this include a luminaire, or just an arm? If luminaire, what is the specification or brand?
 - a. It includes the both the arm and the luminaire. The luminaire should be equivalent to the specification shown starting on pdf page 118 of the bid package.
- **9.** Bid Item 7 & 8: Does this include pole, or just luminaire?
 - a. Both the pole and the luminaire.
- **10.** Bid Item 2,3,6: What is the specific model number of the current luminaires?
 - a. The existing luminaires in the City vary based on the installation date; however, the latest installation is equivalent to the specifications in the RFB package.
