STIPULATED PETITION TO REQUEST MODIFICATION OF MAXIMUM ALLOWABLE RENT TO SUBTRACT PET FEE

For regulated rental units in East Palo Alto, no fees are permitted to be added for housing services beyond those agreed to in the initial rental agreement between a landlord and a tenant, except for a fee to accommodate a pet when the original lease or rental agreement prohibited pets and an amendment is subsequently entered into by the landlord and tenant to allow a pet. To subtract a pet fee from the Maximum Allowable Rent that had been agreed upon by the parties, this stipulated petition must be completed and signed by both the landlord and the tenant and submitted to the Rent Program Administrator to request a modification of the Maximum Allowable Rent. By this means the rent may be adjusted to eliminate this pet accommodation fee and a new certificate of Maximum Allowable Rent will be issued for this tenant.
